The functioning of the nominated teams will be as per following procedure:

- 1. The staff at 'B' above will be stationed at HQ and PNBE. FA&CAO/Con would provide the basic requirements for setting up Camp Office for employees at Construction office Patna.
- 2. The above arrangement is done for targeted work and cease to operate once target is achieved.
- 3. The staff who are being posted at Patna will not be entitled for CTG & joining time.
- 4. The HQ of staff (Sl.4 to 10) will be treated as PNBE for administrative purpose. The Bill unit of the concerned staff will remain at HQ/HJP.
- 5. HRA will be admissible as per extant rules.
- 6. Transportation Allowance will be admissible as per PNBE for staff at SI. 4-10 under 'B' above.
- 7. The teams working at Divisions will be directly monitored by concerned Sr.DFM.
- 8. The staff working in team of HJP/PNBE will report to Sr.AFA/Pension and remain under administrative control of Dy.CAO/G.
- 9. Team 1 of point B will function as co-ordination team and will compile the Inspection Reports of all teams.
- 10. Team 1 will also function as co-ordination team with PNBE based team.
- 11. The 3 member JAG committee constituted for the purpose will be apprised every 15 days regarding progress/achievement of the respective teams.
- 12. Monitoring will be done by Sr.AFA/G & Sr.AFA/Pen at least thrice in a month. Date of monitoring will be fixed by Sr.AFA/G.
- 13. An appraisal report should be put-up to PFA for perusal on 5th of every following month.
