Sub:- Procedure and compliances for the merged Union Territory of Dadra & Nagar Haveli and Daman & Diu

CBIC vide notification No. 10/2020-Central Tax dated 21st March, 2020, had brought out the process for transition of the erstwhile Daman & Diu registration to Dadra & Nagar Haveli. Subsequently, CBIC vide their notification No. 45/2020-Central Tax dated 9th June, 2020 had made effective the transition date w.c.f. 31st July, 2020. Consequent upon these notifications, there will be a single UT as 'Dadra & Nagar Haveli and Daman & Diu' w.e.f. 1st August, 2020. Following process are brought out for GST compliance w.e.f. 1st August, 2020.

In other words, the existing GSTIN registration of Daman & Diu as brought out at S.No. 1 above will cease to exist w.e.f. 31.7.2020 (midnight). Consequently, the GSTIN of the merged UT of 'Dadra & Nagar Haveli and Daman & Diu' will have the GSTIN as mentioned at S.No. 2 above. Western Railway will not use the new GST registration number provided automatically by GST authorities. This needs to be taken up for surrender for which separate communication shall be issued by Board. Instructions for carry forward of Cash Balances lying in the Electronic Cash Ledger of the erstwhile UT Daman and Diu against the registration number mentioned at S.No. 1 above shall also be issued by Board in due course.

Following additional instructions are also brought out for compliance:-

- Old GSTIN of erstwhile UT of Daman and Diu (S. No.1) shall be operational only for compliance purposes i.e. filing of returns for tax period till July, 2020. Hence, no supplies and procurements shall be effected under the aforementioned GSTIN post 1st August, 2020. The same shall be discontinued with effect from 31st July, 2020.
- All the online and offline systems (PRS,FOIS,UTS,IREPS,WARR, PMS, Manual Utility etc.) hosted by CRIS to capture IR's Earning transactions, needs to be validated to accept transactions pertaining to UT 'Dadra & Nagar Haveli and Daman & Diu' w.e.f. 1.8.2020 with GST Registration indicated at S.No. 2 of table on pre-page.
- With regards to procurements and transactions including entering into contracts and issuance of invoices under the merged UT, all such transactions and compliances shall only take place under the existing GSTIN of Dadra and Nagar Haveli (S. No. 2 of table on prepage).
- CRIS may block capture of transaction with GSTIN starting from '25' w.e.f. 31.7.2020 (midnight), as brought out on pre-page.
- Details of GSTIN Numbers of Indian Railways as on 1.8.2020 is attached as Annexure-A.

Strict compliance of the above may be ensured in consultation with GST Consultants for GST compliance. This issues with the approval of competent authority.
